Challenges in the Digital Asset Market

- → The foundation stone for this technological development was laid in 2009 with Bitcoin, the first currency based on blockchain technology.
- → Today, there are more than 31,000 digital assets, of which around 9,000 have a significant and definable volume.
- → The challenge was to develop a selection process to develop an actively managed portfolio with a defined and qualified universe of reputable digital assets.

The Solution

The first regulated AIF authorized in DE and AT for active trading in digital assets. The Teroxx AIF Digital Asset Fund is a PE investment in a company that engages in active trading in digital assets via professional management.


The special feature here is the selection process for the digital assets. Market capitalization, trading volume and the projects underlying the coins and tokens play a decisive role.


This means that only reputable coins with an economic background and representative, stable digital currencies are admitted to the portfolio.

Example 1 An investment of 200,000 \$ in our portfolio on January 1, 2018 would be worth 1,162,599 \$ today.

Example 2

An investment of 1 million \$ in our portfolio on January 1, 2018 would be worth 5,812,998 \$ today.








Track Record of Trading Systems

The results shown below since 2018 are those of the trading systems in Teroxx's own coin for retail customers. The Teroxx Coin is a digital pre-IPO that is scheduled to

be listed on a trading venue as an initial coin offering (ICO) in 2025. The same trading systems were actively launched in the Teroxx AIF fund in September 2023.
